

2024 Summer Learning Opportunities

Site-Funded Summer Learning Opportunities

School leadership may select to use site funds (e.g., strategic budget, Title I, English learners (EL) and At-Risk, 21st Century Community Learning Centers Grant) to host summer learning opportunities for enrolled students, this may include: (a) summer academy, (b) summer school, and/or (c) summer bridge to support student achievement. Based on available site funds, school leadership will determine the days and hours of operation for their summer learning opportunities. The [2024 Summer Learning Opportunities Implementation Guide](#) has been developed to support school leadership with developing and implementing site-funded summer learning opportunities for summer 2024.

School leadership **must** complete a [2024 Site-Funded Summer Learning Opportunities Plan](#) Google survey, even if the school will not offer site-funded summer learning opportunities during summer 2024. School leadership will be required to submit the plan for approval to the Region superintendent by the end of day, Friday, March 29, 2024.

Extended School Year (ESY)

As a component of the Individuals with Disabilities Education Act, specifically Section 300.106, ESY services will provide continued instruction for students with disabilities to retain learning over the summer break. Special education and related services will be provided for students with disabilities, as articulated in each student’s Individualized Education Program (IEP). ESY will operate five days a week for a six-hour instructional student day. ESY credit retrieval options are available for middle and high school students with an IEP who previously failed a core course. ESY will operate at designated schools within the Clark County School District (CCSD). ESY will be available to students enrolled at Nevada Learning Academy at CCSD (NVLA), the District’s online school, during the 2023–2024 school year. Secondary Summer School

Eight high schools (Arbor View High School, Coronado High School, Desert Oasis High School, Liberty High School, Mojave High School, Palo Verde High School, Sunrise Mountain High School, and Valley High School) geographically located throughout the District will host **Secondary Summer School** for middle school and high school students for credit retrieval options and first-time course enrollment for high school students only. Students will not pay for courses. Secondary Summer School will be provided five days a week for a five-hour instructional day during designated sessions.
